



**OFFICIAL RULES  
FANATICS SPORTSBOOK & CASINO FANCASH JACKPOTS (ID: CAS\_5726)**

**NO PURCHASE NECESSARY TO PARTICIPATE OR RECEIVE A PRIZE.  
Purchasing or Betting Will Not Increase Your Chances of Receiving a Prize.**

**1. Description of Promotion**

The Fanatics Sportsbook & Casino FanCash Jackpots promotion (hereafter, "Promotion") is provided by FBG Enterprises Opco, LLC ("Sponsor" or "FBG"). Take the steps outlined in Section 4 below to earn Casino Credit and to be entered for a chance to win a progressive jackpot cash prize (a "Prize"). Prizes are subject to availability and restrictions contained in these Official Rules. Void outside of Michigan, New Jersey, Pennsylvania, West Virginia, and where prohibited by law. All applicable federal, state, and local laws apply.

**2. Promotion Period**

The Promotion begins at 8:00 a.m. Eastern Time ("ET") on November 17, 2025, and ends at 11:59 p.m. ET on May 17, 2026, or when the Mega Jackpot is awarded, whichever comes first (the "Promotion Period").

**3. Eligibility**

- a. To be eligible for this Promotion, during the Promotion Period, you must:
  - i. have an active and verified Fanatics Sportsbook & Casino account in Michigan, New Jersey, Pennsylvania, or West Virginia (an "Account");
  - ii. be physically present in Michigan, New Jersey, Pennsylvania, or West Virginia when you take the actions described in Section 4; and
  - iii. be 21 years of age or older and a legal U.S. resident.
  
- b. The following people are ineligible to participate in this Promotion or receive a Prize:
  - i. Individuals on any involuntary state gambling exclusion list, state gambling self-exclusion list, and/or self-exclusion list for any Sponsor subsidiary.
  - ii. Employees, officers, directors, agents and representatives of Sponsor, and its affiliates, owners, subsidiaries, shareholders, officers, directors, partners, agents, representatives and employees, both individually and collectively; as well as its respective parent companies, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, assignees, advertising and promotion agencies and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related (all of the foregoing, collectively, the "Released Parties").
  - iii. Individuals who are employed by any local, state or federal government office or agency, elected officials and individuals listed on the OFAC Specially Designated Nationals and Blocked Persons (SDN) List.
  
- c. Promotion eligibility is subject to any Account wagering restrictions/limits.

**4. Action Required**

During the Promotion Period, there are two (2) ways to enter for a chance to receive a Prize:

a. **OPT IN AND CONTRIBUTE FANCASH TO THE PROGRESSIVE JACKPOT & RECEIVE CASINO CREDIT:**

- i. To participate in this Promotion by contributing FanCash to the progressive jackpot: (i) access your Account; (ii) navigate to the “FanCash Jackpots” tile on the home page or within any game in the Fanatics Casino and select the option to opt-in; and (iii) place any wager in the Fanatics Casino that is eligible to earn FanCash.
- ii. For details about how FanCash is earned, please refer to FanCash Program Terms, available at: <https://sportsbook.fanatics.com/legal/all/fancash-program-terms>
- iii. Once you’ve opted in to this Promotion, all FanCash that would normally be added to your FanCash balance on your Account according to the FanCash earn rates provided in the FanCash Program Terms, will instead be contributed to the FanCash progressive jackpots described below. Note: if a FanCash multiplier offer is applied to your wager, only the FanCash earned in accordance with the FanCash earn rates in the FanCash Program Terms will be contributed to the FanCash Jackpot, and any FanCash earned from the multiplier offer will be added to the FanCash balance in your Account.
- iv. Once opted-in, you have a chance to win a Prize each time you place a wager that earns FanCash on any game in the Fanatics Casino, and you will remain opted-in to this Promotion unless you opt-out.
- v. To stop contributing FanCash to the FanCash progressive jackpot, navigate to the “FanCash Jackpots” tile on the home page or within any game in the Fanatics Casino, and select the option to opt-out of this Promotion.
- vi. Each \$0.10 of wagering value made while opted into the Promotion counts as one (1) Entry toward the current jackpot draw. An entry gives you a chance to win any of the three (3) Jackpot Prize Tiers.
- vii. For every \$10 FanCash you contribute to the progressive jackpot via this Promotion, you will receive one (1) Reward in the form of \$1 in Casino Credit.

b. **NO PURCHASE METHOD:**

- i. To receive one (1) Entry without contributing FanCash to the progressive jackpot, you may mail a 3”x5” size card including the following information, all handwritten legibly: the name of this Promotion, your full name, full mailing address (no PO Boxes), date of birth, and email address (if you have an Account, please use the email address associated with your Account). To be eligible for a Prize, your Entry must be postmarked no later than the end of the Promotion Period and addressed as follows: FBG Enterprises Opco, LLC – Attn: Casino Operations Team, 1331 17th Street, Suite 900, Denver, CO 80202. You may only receive one (1) Entry per envelope submitted. All no purchase method entries will be tabulated and considered along with all paid entries, at a predetermined weekly day and time. All no purchase Entries must be postmarked no later than the end of the Promotion Period and received no later than five (5) business days after the end of the Promotion Period to be eligible for a Prize.

c. **THERE IS NO LIMIT TO THE AMOUNT OF FANCASH YOU MAY CONTRIBUTE TOWARD THE PROGRESSIVE JACKPOT, OR THE NUMBER OF NO PURCHASE ENTRIES YOU MAY SUBMIT. THERE IS ALSO NO LIMIT TO THE NUMBER OF PRIZES YOU MAY WIN DURING THE PROMOTION PERIOD.**

5. Claiming Promotional Offer

- a. **RANDOM DRAWING & ODDS:** Sponsor will randomly select the potential Prize winners via an automated system configured to trigger the jackpot Prizes at various contribution thresholds. Entries do not carry over, and the prize pool for each jackpot tier resets for the corresponding tier each time that jackpot is triggered. Odds of winning a Prize depend on the number of eligible Entries received at the time of your Entry, and the frequency of the Jackpot Prize tier drawings, as defined below:

- b. **TRIGGERING THE JACKPOTS:** For this Promotion, there are three Jackpot Prize Tiers as follows:
- i. Mini Jackpot: awarded an estimated 20-40 times daily.
  - ii. Minor Jackpot: awarded an estimated 5-10 times daily.
  - iii. Mega Jackpot: awarded a maximum of one (1) time during the Promotion Period.
- c. **CASH PRIZES & CASINO CREDIT REWARDS:** Current Prizes values for the Mini, Minor and Mega Jackpots will be displayed in the App, and Prizes will vary in amount and frequency based on the number of Entries and current FanCash contributed at the time each Prize is triggered. All Prizes will be awarded in USD. Once the Prize has been triggered for any Jackpot Tier, the progressive jackpot pool for that tier only will reset. Prizes will be credited to the winner's Account within seventy-two (72) hours of the jackpot being triggered for Mini and Minor Jackpot Prizes. Mega Jackpot Prizes will be credited following the winner's successful completion and return of the required documentation described in subsection (e) below.

Casino Credit Reward Terms:

- After opting in to this Promotion, for every \$10 in FanCash you contribute to the progressive jackpot prize pool, you will receive \$1 in Casino Credit.
- Your Casino Credit Reward will be credited to your Account within seven (7) days of meeting the FanCash contribution requirement. Casino Credit can be used on any games in the Fanatics Casino and expires seven days from the date of issuance (at 11:59 p.m. ET on the seventh day).
- Casino Credit is a type of bonus issued by Fanatics Sportsbook & Casino that is applied to casino wagers in lieu of (or in combination with) deposited funds (cash).
- You can view your Casino Credit balance in your Account or in the Rewards carousel in the App.
- **If you have Casino Credit available to use, it will automatically be applied to eligible casino wagers before (or in combination with) any deposited funds (cash).**
  - As an example, if you have \$20 in deposited funds (cash) and \$10 in Casino Credit in your Account and you place a \$10 wager that wins \$8, the entire \$10 Casino Credit will be applied to your wager (making your Casino Credit balance \$0), and the \$8 in winnings will be added to your cash balance (making it \$28). Using the same example but with a \$5 wager instead of \$10, your Casino Credit balance will be \$5, and your cash balance will be \$28.
- Casino Credit can be combined with deposited funds (cash) to place a wager.
  - As an example, if you have \$20 in cash and \$10 in Casino Credit in your Account and you wager \$15 on a blackjack hand, \$10 in Casino Credit and \$5 in cash will be applied to that wager.
- Casino Credit must be played through one time.
- Any payouts from bets placed with Casino Credit will be added to your cash balance.
- You do not need to use all of your Casino Credit as a single wager. Your wager amount will dictate how much Casino Credit is applied (e.g., if you have \$10 in Casino Credit and place a \$2 wager, \$2 of Casino Credit will be applied to that wager).
- If Casino Credit is used on a blackjack hand that results in a push, the value of the Casino Credit will be added to your cash balance in your Account (e.g., if you have and wager \$5 in Casino Credit on a blackjack hand that results in a push, your Casino Credit balance will be \$0, but the \$5 stake will be added to your cash balance).
- Casino Credit closest to expiration will be applied first.
- Casino Credit can be transferred between the referenced casino jurisdictions.
- Casino Credit cannot be redeemed for or withdrawn as cash at any time.
- Casino Credit can only be redeemed online or in-app with a valid Account.
- Use of Casino Credit does not count towards qualifying for any other promotional offers, nor can Casino Credit be used in other promotions.
- Bets placed using Casino Credit will not earn FanCash.
- Casino Credit may not be exchanged, substituted, or transferred.

d. **PRIZE CONDITIONS:**

- i. All federal, state, and local taxes, and any other costs associated with receipt, use, and enjoyment of a Prize not specified herein as being provided, are the sole responsibility of the winner.
- ii. All portions of Prizes will be provided “as is” with no warranty or guarantee, either express or implied by Sponsor.
- iii. The Prize recipients may not substitute, assign or transfer a Prize or any portion of a Prize or redeem a Prize for cash or an alternate Prize, but Sponsor reserves the right, at its sole discretion, to substitute a Prize with one of comparable or greater value.

- e. **WINNER NOTIFICATION:** Sponsor’s decisions are final and binding on all matters relating to this Promotion. Following each jackpot being triggered, the potential winner will be notified via in-app message and email that they have been selected (“Prize Notification”). The potential winners may be required to submit a W-9, affidavit of eligibility, liability release, and (where lawful) a publicity release to receive the Prize. If the requested forms are not returned within such seventy-two (72) hour period (if needed), the Prize Notification is returned as undeliverable, Sponsor is unable to contact a potential winner, or a potential winner is not in compliance with these Official Rules, the Prize will be forfeited and, at Sponsor’s discretion, an alternate potential winner may be selected.

6. Casino Registration Procedures

To qualify for this Promotion, you must have an active and verified Account. To create an Account: (i) your identity must be verified; and (ii) you must agree to Fanatics Sportsbook & Casino’s Terms of Service, House Rules, game rules, and these Official Rules, as well as acknowledge our Privacy Policy. You can create an Account for free on the App.

7. Limitations on Participation

- a. Entries generated by script, macro or other automated means, and Entries by any means which subvert the entry process are void. You may only use one Account to enter the Promotion. Entries received from any person or account(s) in excess of the limitation stated above will be void. All Entries become the sole property of the Sponsor and will not be returned.
- b. By participating in this Promotion, each participant agrees:
  - i. to abide by these Official Rules and decisions of Sponsor, which shall be final and binding in all respects relating to this Promotion;
  - ii. to release, discharge and hold harmless the Released Parties from any and all claims, actions, injuries, liability, losses, and damages of any kind to persons, including without limitation, personal injury or death of any winner or third party, or damage to personal or real property due in whole or in part, directly or indirectly, by any reason, resulting, in whole or in part, directly or indirectly, from participant’s participation in the Promotion or any Promotion-related activity or the acceptance, possession, use or misuse of any Prize; and
  - iii. to the use of his/her name, voice, performance, photograph, entry, and/or likeness for programming, advertising, publicity and promotional purposes in any and all media, now or hereafter known, worldwide and on the Internet, and in perpetuity by Sponsor, and its designees, without compensation (unless prohibited by law) or additional consents from participant or any third party and without prior notice, approval or inspection, and to execute specific consent to such use.
- c. When participating in the Promotion, we collect personally identifying information about you, including your name and email address. The information that you provide will be added to a centralized Sponsor database. By participating and providing the required submission information, you acknowledge that Sponsor may email you information, promotional discounts or special offers it believes may be of

interest to you. Your information will not be sold or rented to third parties. If you would like your information removed from this database you can do so at any time by following the opt-out instructions at the bottom of any email correspondence received from Sponsor. For more information about how Sponsor uses the information you provide, see [Sponsor's Privacy Policy](#).

- d. Prize fulfillment may require sharing your personal information with our affiliate, Fanatics, LLC. Such information will be handled by Fanatics Commerce in accordance with its posted [Privacy Policy](#).
- e. By participating, each participant also agrees not to release any publicity or other materials on their own or through someone else regarding their participation in the Promotion without the prior consent of the Sponsor, which it may withhold in its sole discretion.
- f. Sponsor expressly reserves the right to amend, suspend or terminate this Promotion, including the administration thereof, at any time without prior notice or consent. In addition, Sponsor, in its sole discretion, may disqualify you from participating in this Promotion for any reason, and this Promotion is void in any jurisdiction where prohibited by law.

#### 8. Wagering Requirements/Exclusions

All eligible wagers that earn FanCash under the FanCash Program Terms (<https://sportsbook.fanatics.com/legal/all/fancash-program-terms>) will count toward Entries for the progressive jackpot Prize. Only wagers placed with cash are eligible. Wagers placed with Casino Credit, Free Spins, or any other promotional credit will not contribute FanCash toward the progressive jackpot and will not qualify to trigger a Prize.

#### 9. Order of Funds Used For Wagering

If you have Casino Credit available to use in your Account, it will automatically be applied to eligible casino wagers before (or in combination with) any deposited funds (cash). To place a bet using a Free Spin, select "Free Spin" in the slots game. If you do not have Casino Credit in your Account, or if you do not apply any Free Spins you may have, then bets will be placed with deposited funds (cash).

#### 10. Eligible Games

Cash wagers placed on any games in the Fanatics Casino after opting-in will contribute FanCash to the progressive jackpot, and will have a chance of triggering the progressive jackpot Prize.

#### 11. Restrictions on Withdrawal

Casino Credit, Free Spins, Bonus Bets, FanCash, or any other promotional credits may not be withdrawn or redeemed for cash at any time, but any winnings from bets placed with promotional credit can be withdrawn once the winnings have been added to your Account cash balance. Casino Credit must be played through one time. There are no playthrough requirements on Free Spins.

#### 12. Cancellation

To cancel your participation in this or any promotion, please contact customer support within the App.

- b. In the event of any inconsistency between these Official Rules and the relevant corresponding provision of Sponsor's Terms of Service, these Official Rules will prevail.
- c. If you have a question about participating in this Promotion, including any in-app offers or bet placement questions, please contact Fanatics Sportsbook at the customer service link section of the mobile application.
- d. The tabulation of Entries, and identification of Prize recipients will be conducted by Sponsor whose decisions are final and binding on these and all other matters relating to the operation of the Promotion. In order to participate, participants must agree to these Official Rules.
- e. In the event of a dispute as to the identity of a participant, registration will be deemed from the person named on the applicable Entry form (regardless of whether that is the name of the authorized Account holder of the email address submitted with the Entry), provided such individual is eligible according to these Official Rules.
- f. Released Parties are not responsible for lost, late, incomplete, damaged, inaccurate, stolen, delayed, misdirected, undelivered, or garbled Entries, or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Promotion, including, without limitation, errors or difficulties which may occur in connection with the administration of the Promotion, the processing of Submissions or questions, the announcement of the Prizes, or in any Promotion-related materials. - i. **ARBITRATION AND CHOICE OF LAW:**
  - i. Except where prohibited by law, as a condition of participating in this Promotion, participant agrees that (1) any and all disputes and causes of action arising out of or connected with this Promotion, or any Prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American

- Arbitration Association and held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration prize may be entered in any court having jurisdiction.
- ii. Under no circumstances will participant be permitted to obtain Prizes for, and participant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than participant's actual out-of-pocket expenses (i.e., costs associated with participating in this Promotion), and participant further waives all rights to have damages multiplied or increased.
  - iii. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of New York, USA.
